1. This list is purely provisional and is based on the data provided by candidates as submitted.																							
2. Final merit lists will be published after thorough verification. A detailed schedule for the entire admission process and related activities will be made available soon on the official webpage and Facebook page of KMU.																							
3. Inclusion of candidates in this provisional merit list does not guarantee admission in a medical or dental college. If a candidate is found ineligible at any stage due to errors, mistakes, fraud, or misrepresentation, their admission will be revoked. According to Clause 38 of the Admission Policy 2025-26: <b><i>“All admissions will be provisional. All certificates or any other documents submitted with the application form will be subject to verification by the respective colleges. Any candidate whose documents are found incorrect or false / forged in any way, or whose authentication is doubtful, rendering him/her ineligible for admission under the rules, will be struck off from the college roll and legal action may be taken under the criminal and civil law against him/her.”</i></b>																							
4. Candidates may file complaints online at <a href="https://cas.kmu.edu.pk/complaint.php">https://cas.kmu.edu.pk/complaint.php</a> regarding any errors, omissions, lapses, mistakes, fraud, or misrepresentation in this list by Sunday, 7th December 2025, before 4:00 PM. Complaints can only be submitted using the candidate's registered CNIC number (entered during account creation on the online portal) and must include documentary proof (e.g., result card) to support the claim. Complaints without valid proof will be rejected. Hard copy complaints will NOT be accepted, and there is no need to visit the university for this purpose.																							
5. To address deficiencies mentioned in the provisional merit list, candidates must log in to <a href="https://cas.kmu.edu.pk">https://cas.kmu.edu.pk</a> using their CNIC number and password.																							
6. No complaints or applications will be accepted after 4:00 PM on 7th December 2025.																							
7. As per Section 3 of PM&DC regulations 2025 and KMU Admission Policy 2025-26, candidates with less than 60% marks in HSSC/equivalent or less than 55% in MDCAT 2023, 2024, and 2025 are ineligible for admission to MBBS. Similarly, candidates with less than 50% marks in MDCAT 2023, 2024, and 2025 are ineligible for admission to BDS.																							
8. Remarks mentioned against a candidate in one category, i.e, OPEN MERIT, will be applicable to other relevant categories like General Self Finance etc.
